Notice of Establishment of Business Alliance with IQVIA Solutions Japan

Japan System Techniques Co., Ltd. (JAST) has started a business alliance concerning joint activities involving the healthcare business with IQVIA Solutions Japan K.K. (Head office: Minato-ku, Tokyo; President: Fumihiko Ugajin), a subsidiary of IQVIA Holdings Inc. (IQVIA), which is based in the United States and has operations worldwide.

1. Background and purpose of the alliance

IQVIA is one of the world's leading organizations for the provision to companies in the life sciences sector of advanced analytic services, technologies for innovations and clinical trial services. Products and services support the clinical development and commercialization of revolutionary treatments that improve outcomes for patients. Another strength is the creation of intelligent connections by leveraging extensive knowledge and insight that can be used rapidly and revised to reflect a variety of changes. IQVIA has a workforce of about 82,000 in more than 100 countries and regions. The operations of IQVIA Solutions Japan are primarily in Japan.

JAST used ICT expertise acquired over many years to develop JMICS (JAST Medical Insurance Checking System), which started in August 2010. This system speeds up and automates the inspections and analysis of monthly invoices for medical services that are sent by healthcare institutions to patients. In addition, JAST used JMICS as the base for the launch in April 2013 of a medical big data business. To be a provider of data health solutions, this business covers a broad range of activities including the utilization of health checkup and other external data, many types of analysis and notification services, and other services.

JAST creates services with the goals of converting medical data to an asset with value and of using ICT for the digital transformation of the business procedures of insurers. The company's mission is to use these services to extend the healthy life spans of the public and support health insurance for the people of Japan. Operations include the analysis of medical expenses and business consulting for the health insurance. There are also operations extending from notifications to a variety of guidance for staying healthy in order to encourage people to alter their behavior to improve their health. These capabilities allow JAST to provide one-stop support for the data health plans of health insurers. JAST provides services to more than 300 health insurance organizations throughout Japan, including local governments, health insurance societies and other types of insurers.

The Future Co-creation Laboratory of JAST builds and provides medical big data by using health insurance invoice and health checkup data, all of which is anonymous, of more than 8 million people. The lab works with healthcare companies to develop new products and with universities for joint research projects. Activities of the lab are aimed at playing a role in solving a diverse array of social issues involving healthcare and staying healthy.

The business alliance is expected to facilitate the effective utilization of the services, knowledge and accomplishments of both companies in the medical big data sector. Strengthening and creating services for leading a healthy life style and ensuring a suitable level of expenses for healthcare is one goal. Another goal of the alliance is to make an even greater contribution to solving social issues in the healthcare sector.

2. Outline of the business alliance

JAST and IQVIA Solutions Japan have reached an agreement regarding the following activities concerning the business alliance. The two companies will continue to hold discussions for the purpose of using this alliance to achieve the above goals.

The medical big data of JAST and IQVIA will be combined in order to use the knowledge and experience of these companies for the creation and provision of new services and solutions by using a database encompassing more than 13 million individuals.
